IFRA Class	Finished Product Types
1	Leave on products generally applied to lips: Lip products of all types (solid and liquid lipsticks, balms, clear or colored lip wax, etc.), Children's toys
2	Leave on products generally applied to axillae (or the body): Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm), deo-cologne aerosol sprays, Body sprays (including body mist)

11A	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate: Feminine hygiene conventional pads, liners, interlabial pads, Diapers (baby and adult), Toilet paper (dry), Adult incontinence pant, pad
11B	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate: Tights with moisturizers, Scented socks, gloves, Facial tissues (dry tissues), Napkins, Paper towels, Wheat bags, Protective facial masks in paper e.g. surgical masks but not used as medical device, Fertilizers, solid (pellet or powder), Pillow spray
