4.1 Description of first aid measures

General notes

Never give anything by mouth to an unconscious person. Place patient in recovery position and ensure airway patency. When in doubt or if feeling unwell seek medical assistance. Show the safety data sheet and label to the physician. No action shall be taken involving any personal risk or without suitable training. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Following inhalation

Do not induce vomiting! Rinse mouth thoroughly with water. Never give anything by mouth to an unconscious person. Immediately consult a doctor. Show the physician the safety data sheet or label.

4.2 Most important symptoms and effects, both acute and delayed
