To the best of our knowledge, this product contains the following maximum percentage of naturally occurring ingredients listed as the 82 fragrance allergens in the **Commission Regulation (EU) 2023/1545 of 26 July 2023**, amending **Annex III** of the **Cosmetics Regulation (EC) No 1223/2009** as regards labelling of fragrance allergens in cosmetic products. These substances must be mentioned in the list of ingredients if their concentration exceeds **0.001%** in leave-on products and **0.01%** in rinse-off products.

Concentrations are given in % weight in the formula. Concentrations indicated as "-" indicate that the substances are <1ppm and generally below the level of detection using the standard methods developed by the International Fragrance Association (IFRA) (*Chaintreau et al., 2003, J. Agric. Food Chem., in press, and the Method for analysis of allergens EN16274:2021 - Quantification of an extended list of 57 suspected allergens in ready to inject fragrance materials by gas chromatography mass spectrometry*).
