6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective, equipment and emergency procedures: (Methods and materials for containment and cleaning up) Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor. Keep unnecessary personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them. Collect and dispose of spillage as indicated in section 13 of the SDS. Absorb with inert absorbent such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps. The product is immiscible with water and will spread on the water surface. Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Never return spills in original containers for re-use.
